MEETING

FINANCIALS

Kay DeCuir noted that our local shops are doing phenomenal. She also shared she would be presenting a workshop on April 27th entitled, "Essence of Customer Service" for our local businesses.

Kay noted

- the February 2019 Financial Reports list our total tax revenue as eighty thousand six hundred sixty-five dollars and .97/100 (\$80,665.97).
- the projected 2018 2019 Budget is eight hundred forty-nine thousand three hundred forty-seven dollars and no/100 (\$849,347.00) and at this time we are almost halfway through the year with a total revenue to date of four hundred sixty-two thousand eight hundred seventeen dollars and .81/100 (\$462,817.81). We need three hundred eighty-six thousand five hundred twenty-nine dollars and .19/100 (\$ 386,529.19) in revenue to meet our goal.
- Certificate of Deposit at 5Point is due to mature in April and she has negotiated a renewal fixed rate of 2.75% for 12 months beginning in April. Kay stated that Board VP Brian Swindel agreed to be the new signer on the 5 Point CD.

COMMUNICATION

Kay shared the following:

- Hargrove Engineering will open April 1
- Mexican Ice Cream Shop has opened on Nederland Avenue
- La Salsita Express Take Out will be opening in the former Kimball Creamery building
- A new business recently signed a lease for a space in the K & S Plaza on Nederland Avenue and will be submitting an application for an incentive
- A new business is currently negotiating to lease a building on Boston Avenue and will be submitting an application for an incentive

- Market Day will be Saturday, May 4th on Boston Avenue
- We will be updating the EDC's website and have reached out to Region V to update it for a cost of \$2,950.00 to design and host for one year.
- The SETX Regional Economic Foundation Video will be updated to include Entergy Transfer and we have received the script, photos and details from Entergy Transfer.
