- City Sales & Use Tax Comparison Summary Nederland's City Sales & Use Tax exceeds the cities of Groves, Orange and Port Neches.
- Excess Revenue over expenses: June Revenue- \$83,048.39. Total Revenue YTD exceeds budgeted revenue by \$108,000.00 and we have three months remaining in fiscal year
- June Sales Tax received \$82,575,54
- Spoke with Cheryl Dowden, City Finance Director and we will have an excess of over \$200,000.00 over budget. We've had another good year and this overage will help off set the cost of property purchases.
- Special Programs total budgeted \$500,000.00 waiting for several projects to be completed to pay out. We have approximately \$32,000.00 remaining in a PRIDE Program with a few remaining to be paid out for this fiscal year. Any remaining monies in these categories may be moved to line items with negative balances. We have a few line items that we had not budgeted, as we had not planned to purchase properties, that have negative balances.

They are requesting five hundred eighty dollars and .44/100 (\$580.44) on a project totaling one thousand one hundred sixty dollars and .88/100 (\$1,160.88).
