- Market 409 will be moving forward with a small craft market in April on the bank parking lot between the Bank Building and The Golden Cup. A draft of the agreement was shared with the Board for review. If there are no issues with the April market, the NEDC will go forward with a 90 Day agreement with Market 409.
- Sassy Trendz informed the NEDC of a monthly Market they will sponsor from April through September on the vacant lot next to their building. They will be donating the booth fees to a different Charity each month
- The Nederland Heritage Festival has submitted a Certificate of Insurance for the use of the Bank Parking Lot for the annual Car Show to be held on Saturday, March 19, 2022
- Chamber of Commerce is planning a Candidate Forum for the upcoming School Board Elections.
 Since there will be a runoff election for our Precinct 2 Commissioner and both Candidates are from Nederland, Kay proposed the NEDC host a Candidate Forum for these two candidates to be held in April.
