EMPLOYEE BENEFIT CHANGE PLAN

A motion was made by Anthony Toups and seconded by Bret Duplant to approve NEDC Employees renewal of Health Care PPO Plan, same as the city, through Blue Cross Blue Shield with a \$1,500.00 deductible and a \$6,500.00 maximum out of pocket, at a cost of \$687.39 per employee paid 100% by NEDC for the 2022-2023 plan year, effective July 1, 2022. Included in the package is the NEDC Employees Dental Insurance through Blue Cross Blue Shield at a cost of \$25.31 per employee paid 100% by NEDC 2022 – 2023, effective July 1, 2022. (Vison coverage is voluntary and paid 100% by employees)

FINANCIALS

Kay DeCuir shared the Financial Reports as of April 2022, (February 2022 data). The City Comparable Report, comparing the Current Year to Prior Year Sales Tax Revenue by City, shows an 8.31% increase for Nederland. The Sales Tax received for February 2022 was \$102,272.70 with a Total Revenue of \$117,478.68, which includes Rental Income, Interest Income and Miscellaneous Income. Seven months remaining to meet budgeted Revenue. Kay will work with Cheryl Dowden for money received for sale of land to allocate funds for downtown revitalization. Kay noted pay out to Jiffy Trophies under the PRIDE

Program was made. After current PRIDE applications approved, we will have approximately \$53,000.00 remaining in the PRIDE Program budget for this fiscal year.

COMMUNICATION

Kay DeCuir shared the following with the Board;

- She has been writing a lot of grants
 - Wrote, qualified and received a \$5,000.00 grant from Sempra. This is an Environmental grant which will be used to plant trees and landscaping at the Atlanta Street project once construction is complete. Sempra has also requested to help with the planting and landscaping.
 - State EDC Grant for revitalization of trees and grass. Betty Russo with the State said we have a good chance in receiving a grant.
 - City of Nederland for non-profits. Applied for Professional Development Training for Job Creation. All submitted except for one item which she is working on. She spoke with City Clerk, Gay Ferguson, and was informed the deadline has been extended.
- Checkers has installed a temporary utility pole on the Nederland Avenue property
- She will apply for the Community Economic Development Award, sponsored by Texas Economic Development Council, for our Boston Avenue Building Project
- Gave update on the Market 409 held in April and future dates
- Intern from University of Texas will begin working at NEDC on 05/31/2022 through August.
- Working with Jerry Diaz on 2022 Fall Concert Series
