They are requesting ten thousand dollars and 00/100 (\$10,000.00) on a project totaling twenty-seven thousand four hundred ninety-five dollars and .50/100 (\$27,495.50).

A motion was made by Billy Wayne Doornbos and seconded by Mike Roebuck to approve the PRIDE Program application for Heritage Express Car Wash in an amount not to exceed ten thousand dollars and 00/100 (\$10,000.00).

COMMUNICATION

Kay DeCuir shared the following with the Board;

- Financials once again are strong. We have increased our sales to 5.65% over sales in 2021 at this time last year. Working currently on the audit files with our auditors.
- October through December the NEDC has competed the 125 Anniversary Scavenger Hunt, Fall Market Day (our largest ever), 2022 Fall Concert Series, The Golf Cart Tour of Lights and our new marketing commercials in Texas and Louisiana for Shop Local, Shop Often, Shop Nederland Campaigns.
- We started surveying on Atlanta Avenue for the future development. The project will be underway
 in January 2023.
- In 2022 the NEDC acquired many properties and now is the time to begin work on those projects.
- Kay requested committees to be assigned to assist in the upcoming projects of the NEDC. She requested a committee for the Bank Building/Event Center and a committee for the Atlanta Avenue Expansion Project. Mike Roebuck, Bret Duplant and Sylvia Root volunteered to assist with the Atlanta Avenue Project. Anthony Toups, Billy Wayne Doornbos and Mitch Macon offered to work on the Bank/Event Center.
- Quotes for interior demo of the Bank/Event Center will begin in January 2023.

- On January 12, 2023 the Southeast Texas Economic Development Foundation will host its annual luncheon. A table has been reserved for the NEDC Board of Directors.
- April 2023, Cheryl Dowden will begin work with NEDC as our Financial Manager and we will begin work on her contract in the near future.
- Kay will work with the Nederland High School or possibly hire someone at minimum of 5 hours a week to help with clerical/filing in January if needed.
- Kay will have an intern from UT for June-July 2023.
- Kay will be on vacation Friday, December 16th through Monday December 19th.
- NEDC will be closed the same holidays for Christmas as the city.
