## COMMUNICATION

The Director shared the following with the Board:

- Last board meeting in July, Billy Wayne Doornbos asked the Nederland EDC to get quotes on insurance for vehicles of the staff at Nederland EDC. We currently have D&O Liability Insurance coverage but will continue to shop for better coverage and rates to be presented at the next meeting. We are waiting on quotes for General Liability, Hired & Non-Owned Auto Liability, Directors & Officers Liability and Employment Practices Liability.
- Once Off Boston Development gets power in approximately 3 weeks, we can start moving along with finishing the development.
- Nederland EDC started accepting vendor applications on August 15. We now have 46 vendors out of the 121 vendors allowed for Fall Market Day to be held on October 19.
- Port-A-Potties and barricades have been ordered for the concert series and Fall Market Day.
- The Director will be attending the TEDC conference this fall. We were nominated for the TEDC award by Small Business Development Center for the Off Boston Development.
- The commercial for the concert series is free with 12News because of us purchasing a commercial for the Fall Market Day and working with them so often. The commercial for the Fall Market Day is announcing the day, time, and location.
- For the Celebration of Businesses, each will get to announce how long they have been in business in Nederland. The Director will pick up the awards tomorrow, and we will mail out the invitations 30 days before the celebration.
- August 6, the NEDC held a workshop at First Baptist Church Nederland with the COVID Grant the NEDC received a few years ago. It went really well with 10 participants. We are partnering with the Port Arthur Chamber to have a workshop on Quick Books for November 14. It will be held at the regional airport.
- Boots and Bulls is September 26, NEDC has a table.
- The bank drive-thru had a window broken a few weeks ago. The Nederland Police Department notified us of this and we had a contractor patch up the window until we can have the bank drive-thru torn down. The Director will get quotes on demolition and will let the Board know.
