- Kay and her husband wrapped the pipes for all NEDC properties before the freeze.
- The Nederland Chamber Board Installation has been rescheduled to February 1, 2024 due to the freezing weather. Business of the year will be Buckstin Brewing and the non-profit of the year is Grant's Guardians.
- All records are up to date with JCAD for all NEDC Properties.
- The Nederland Heritage Festival will host their kick-off and announce Mr. Nederland on January 23, 2024 at 5:00pm.
- The City of Nederland is hosting a Municipal Government Academy. Kay will present a class on Economic Development on March 4, 2024.
- 1132 Atlanta Avenue Suite 101, Model F submitted their earnest money and signed LOI. The contract will be created and signed within a week. The potential new property owner has already met with the Architect for changes to the building at the buyer's expense. Construction is moving well. There are potentially 2 other buyers and Kay is having meetings at this time for LOI's and contract signings.
- All selections for exterior and interior construction have been selected down to the hinge colors for the Off Boston Destination development.
- Kay meets the last Monday of each month with the architect and contractors on the Off Boston Development for updates.

- We have Cheryl Dowden coming on board in February and our Intern from UT Austin will begin in May 2024.
